ILL.: DONALD DAVIS THOMAS, 33°


Ill.: Brother Donald Thomas, 33°, was born in Rochester, New York on June 3, 1931. He was the youngest of five children of Leslie G. and Francis Thomas. He attended the public school systems in New York, Connecticut, Pennsylvania, and New Jersey. He earned his Master of Science degree in Mechanical Engineering from the University of Pennsylvania, where he also taught in the School of Engineering for three years. Following University, he entered the Aerospace Industry participating in numerous space programs.

He met his wife Pamela Brewell, of Cheam, Surrey England when she came to visit his sister in 1949. Following five years of long distance correspondence, and the completion of his undergraduate degree and first year of Graduate School, Don and Pam were married in Christ Church, Sutton England in September of 1954. With members of both families still residing in England, they enjoyed frequent trips to Europe. He retired from the Elkton Division of Thiokol Corporation where, for 36 years he was manager of their Information Systems Department.

Ill∴ Brother Donald had been a member of the Masonic fraternity for over 35 years. During this time he had served his mother lodge, Hiram Lodge Number 25, the Grand Lodge of Delaware, and Freemasonry across many borders. He was Worshipful Master of his Lodge in 1978 and served as Senior Grand Deacon of the Grand Lodge of Delaware. He was elected Deputy Grand Master in March 2003 and installed as Grand Master in October of 2004.

Thoroughly enjoying the ritual, as well as the studies of Freemasonry, Ill∴Brother Don actively participated in the activities of the Craft whenever and wherever possible. He was crowned a 33rd degree Scottish Rite Master Mason on September 26, 1979. He was crowned an Active Member of the Supreme Council of the Northern Masonic Jurisdiction, Ancient Accepted Scottish Rite of Freemasonry in September 2000, and became Deputy for Delaware in September 2002. He was appointed as the Intendant General for Delaware of the United Imperial Council, Red Cross of Constantine in June 1989. He was a member of the Jesse Green Priory No. 70, Knights of the York Cross of Honour, where he served as Prior and Recorder-he proudly wore four quadrants in that body. Ill: Brother Donald also served as Dad to the Robert S. Gallagher Chapter of DeMolay in 1979 and he received the Honorary Legion of Honor, Delaware Preceptory. He was also past presiding offer of Delta Chapter Number 6, Royal Arch Masons, Gunning Bedford Council Number 1, Royal and Select Mason; St. John's Commandery Number 1, Knights Templar, Keystone Council Number 113, Allied Masonic Degrees; Delaware Council Number 18, Knight Masons; Two by Two Lodge Number 15, Royal Ark Mariners; First State York Right Collage Number 45, Order of the Purple Cross; Chief Adept Emeritus of Delaware College, Masonic Societas Rosicruciana In Civitatibus Foederatis; a member of Brandywine Forrest Number 20, Tall Cedars of Lebanon and Grand Masters Chapter Number 996, National Sojourners. He was also a member of the Ohio Chapter of Research, Quatuor Coronati Lodge Number 2076, London England, for which he had been the local Secretary for Delaware for 35 years, and is a Life Member of the Missouri Lodge of Research.

Outside of the Fraternity, Donald and his wife Pam were active members of the Newark Community and the United Methodist Church. Donald served his church as the Head Usher for the 9:30 am service for over 35 years. In addition they both continued to serve on a large number of Committees of the Methodist Church. Donald also was very active in Boy Scout Troop 255, located in Newark, and served as the church coordinator for that troop for 15 years.





ILL: JAMES T. ELLIOTT, JR., 33°

James T. Elliott, Jr., age 71, passed away on August 14, 2018 at Christiana Hospital. He was born and raised in Wilmington and was the son of the late Lillie J. and James T. Elliott, Sr. He graduated from P.S. du Pont High School in 1964 and joined the U.S. Navy Reserve at the age of 17. Jim graduated from Widener University where he received a bachelor's degree in science. Jim proudly served his country in the U.S. Navy, on the destroyers, USS Dewey and during the Vietnam War on the USS C. V. Ricketts. He worked in the machine maintenance department for the U.S. Postal Service in the main post office in Wilmington, then in New Castle. Jim then worked for the former MBNA in consumer deposits and retired as a branch manager in 1994 after 8 years. He was a member of St. John's Lodge #2 A.F. & A.M. in New Castle where he served as Worshipful Master in 1988. Jim was an Active 33° member of the Scottish Rite Valley of Wilmington. He was a member of the Supreme Council and a Past Deputy for the State of Delaware. Jim belonged to Delta Chapter #6 R.A.M., Gunning Bedford Council #1, St. John's Commandery #1 K.T., First State York Rite College #45 receiving the Order of the Purple Cross in 2008, Jesse Green Priory K.Y.C.H. #70, Delaware College S.C.R.I.F., Delaware Council of Knight Mason #18, Keystone Council #113 Allied Masonic Degrees, Two-by-Two Lodge #15 Royal Ark Mariners, Delaware Conclave Red Cross of Constantine, and Wilmington Masonic Hall Company.

He is survived by his wife of 48 years, Carolyn (Money) Elliott, his brother-in-law Carlton C. Money and his wife, Shirley and several aunts, uncles, and cousins. Jim was preceded in death by his brother, John R. Elliott.

Message From our New Active

The "Blue Envelop Appeal Challenge"

Good day brethren and before I begin with what I have to say allow me to express my sincerest and heartfelt thanks to III. Bro. Herbert J. Atkinson, Active Member of the Supreme Council for the NMJ and Deputy for Delaware for his confidence in me to participate as part of his leadership team as an Active Member of the Supreme Council and Active for Delaware. I also want to thank every one of you for your support, encouragement, and words of inspiration as I assume this new role. I look forward to working toward advancing our mission alongside the finest group of men I have ever come to know. Thank you again.

Now, the **Blue Envelop Appeal Challenge** . . . You probably saw in this year's Blue Envelop Appeal notice that the Supreme Council is challenging all the Valleys in the NMJ to engage in a bit of "Friendly" competition. This challenge comes in three flavors: (a) top 10 Valleys for the percent of membership donating, (b) top 10 Valleys for the number of members donating, and (c) top 10 Valleys for the amount of money donated. Competition can take many forms (against oneself, against a standard, against nature, and of course against others). Each form has its advantages and disadvantages, and usually when competing against others, as is being challenged here, there are usually more losers than winners, HOWEVER that is not the case with this "Friendly Challenge" for our charities will be on the receiving end and those to whom these charities benefit will certainly be the winners, hence there are NO LOSERS so let's get on board.

The way I see it, the Valley of Wilmington might be challenged to compete with the larger Valleys for total number of members contributing and total amount donated, BUT the advantage of being a smaller Valley is that we can win the percentage competition if we can just get everyone to SEND SOMETHING. Too often we think that we cannot afford to be benevolent but remember the story of the women in the Gospel of Luke (21:1-4) who put into the temple treasury two copper coins compared to those who were giving out of abundance and how favorably she was looked upon. So I ask, can everyone donate at least \$5 to this year's Blue Envelop Appeal? Of course you can always give more but I challenge everyone to send something. As of this writing we are currently in 3rd place in the percentage category at 6.25%, just behind Birmingham, NY at 6.37% and Lancaster-Littleton, NH at 7.44%. Let's blow the top off this challenge by getting over 90% of our membership to donate something and thus help our Brothers and their families whether it be through the Grand Almoner's fund, Abbott Scholarship fund, Children's Dyslexia Centers, or our Masonic Museum and Library. Remember there are NO LOSERS, only WINNERS and that includes you.
